Material and Objects in Contact with Food

that the articles belonging to the following product ranges:

NOVAX SERIES ELECTRIC PUMPS - ARE COMPLIANT

With EC Regulation 1935/2004 of the European Parliament and of the Council of 27 October 2004 on materials and objects intended to come into contact with foodstuffs and repealing Directives 80/590/EEC and 89/109/EEC. With EC Regulation 2023/2006 of the Commission of 22 December 2006 on good manufacturing practices for materials and objects intended to come into contact with foodstuffs. The articles of the aforementioned series have been produced with the following

COMPONENTS:

- Acetal resin cover, impeller, pump body, stainless steel shaft, NBR gaskets, hose holder;
 - Alloy type g-cu zn37 ph2 ni1 alfe-b designation en 1982-cb753s;
 - Acetal resin pom;
 - Surface treatment phosphorus-based metallization.

These materials comply with the applicable Community provisions concerning materials and objects intended to come into contact with food products. Consequently, the products meet the requirements of the European Regulations as listed above. In particular, the different types of materials used and employed in contact with food meet the relevant applicable requirements. In the absence of the specifications referred to in Article 5 of EC Regulation 1935/2004, the provisions set out in the following national standards have been adopted:

- Ministerial Decree No. 34 of 21 March 1973, Hygienic discipline of packaging, containers, utensils intended to come into contact with food substances or with substances for personal use and subsequent updates and modifications;
- Art. 1, art. 3, art. 4 paragraph 5, art. 6 of the Presidential Decree of 23 August 1982, n° 777, implementation of Directive (EEC) n° 76/893 and subsequent amendments, starting from the entry into force of Legislative Decree of 10 February 2017, n° 29, Sanctioning provisions for violation of provisions of EC regulations on materials and objects intended for contact with food products and foodstuffs;



- Ministerial Decree n° 72 of 9 May 2019, regulation containing the update to the Decree of the Minister of Health of 21 March 1973 "Hygienic discipline of packaging, containers, utensils intended to come into contact with food substances or with substances for personal use" limited to stainless steels.

For metal alloys other than aluminum and stainless steel, including surface treatments, as there are no specific measures at national and/or community level, suitability has been assessed according to the principles of art. 3 of EC Regulation 1935/2004.

Specifications for use:

Use temperature: max 35° C
Foods with pH between 4 and 8

To allow official controls to be carried out in accordance with the provisions of EC Regulation 882/2004 by the territorially competent health authority at the establishment that carries out the activities referred to in EC Regulation 2023/2006, it is hereby declared that ROVER POMPE SAS has provided, at the same time as starting its activity, the notification for the granting of the health registration provided for by Legislative Decree 29/2017 – art. 6, paragraph 1 of the production site in Polverara (PD), Via Dell' Artigianato. It is the user's responsibility to verify the possible suitability of the products for use with the specific food/foods under the conditions of use.

ROVER POMPE SAS recommends carrying out a circuit wash cycle using detergent products with a concentration suitable for domestic use. It is also the responsibility of industrial and commercial operators to maintain the traceability of the products supplied. All supporting documents relating to this declaration, including documentation relating to the tests carried out on the products, and suitable for demonstrating the conformity of the products are available to the Competent Authorities upon request, at the offices of ROVER POMPE SAS.

This declaration is valid from the date indicated below and will be replaced in the event of substantial changes in the production of the materials capable of changing the essential requirements for compliance or when the legislative references cited in this declaration are modified and/or updated in such a way as to require a new verification for compliance.
